

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 6, 2012, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a Special Municipal Election was held and conducted in the City of Commerce, California, on Tuesday, November 6, 2012, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the *Elections Code* of the State of California for the holding of elections in general law cities; and

WHEREAS, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COMMERCE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts of the City except vote by mail voter ballots was 3,281.

That the whole number of vote by mail voter ballots cast in the City was 668, making a total of 3,949 ballots cast in the City.

SECTION 2. That the measure voted upon at the election is as follows:

MEASURE A. SHALL THE ORDINANCE IMPOSING A ONE-HALF OF ONE PERCENT (½%) TRANSACTIONS AND USE (SALES) TAX TO OFFSET SEVERE STATE BUDGET CUTS AND PROVIDE FUNDING FOR SUCH THINGS AS POLICE AND FIRE SERVICES, REPAIR, MAINTENANCE AND IMPROVEMENT OF STREETS, SIDEWALKS, PUBLIC FACILITIES, PARKS, LIBRARIES AND OTHER CITY SERVICES, WITH ALL REVENUES STAYING IN THE CITY AND SPENDING REVIEWED BY A CITIZENS' ADVISORY PANEL AND INDEPENDENTLY AUDITED, BE APPROVED? SECTION 3. That the number of votes given at each precinct and the number of votes given in the City for and against the measure were as listed in Exhibit "A", attached.


SECTION 4. The City Council does declare and determine that:

As a result of the election, a majority of the voters voting on the measure relating to an Ordinance imposing a one-half of one percent (½%) transactions and use (sales) tax to offset severe state budget cuts and provide funding for such things as police and fire services, repair, maintenance and improvement of streets, sidewalks, public facilities, parks, libraries and other city services, with all revenues staying in the City and spending reviewed by a citizens' advisory panel and independently audited, did vote in favor of it, and that the measure was carried and shall be deemed adopted and ratified as Ordinance No. 649.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The measure voted upon; (3) The number of votes given at each precinct for and against the measure, and (4) The total number of votes given for and against the measure.


SECTION 6. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
